

#### ANNUAL MANAGEMENT DISCUSSION AND ANALYSIS

#### 1.1 Date

The following management and discussion and analysis (MD&A) for Hard Creek Nickel Corporation (the "Company") is for the year ending December 31, 2016 and includes information up to April 11, 2017 (the "Report Date"). The MD&A should be read in conjunction with the Company's audited financial statements and related notes to the financial statements for the period ended December 31, 2016. All amounts are expressed in Canadian dollars unless otherwise stated.

This Management's Discussion and Analysis is a review of the Company's operations and financial position as at and for the year ended December 31, 2016, and plans for the future based on facts and circumstances as of April 11, 2017. ## **1.2** Overall Performance

The Company has a 100% interest in the Turnagain Nickel property located in the Liard Mining Division in northern British Columbia, approximately 70 km east of Dease Lake. The 65 claims that comprise the Turnagain property are contiguous, and as of the date of this report, cover an area of approximately 33,220 hectares. All of the property claims have had assessment work applied to them to keep them in good standing until at least December 1, 2021.

The Turnagain project was placed on care and maintenance during the second quarter of 2016.

The Company relies on equity financings and loans to fund its operations. During the year ended December 31, 2016, The Company issued 25,000,000 units for gross proceeds of \$250,000, each unit consisted of one common share and one share purchase warrant. At December 31, 2016, the Company's working capital was \$89,698.

#### **1.3 Selected Annual Information**

### **1.4 Results from Operations**

General and Administrative - During the year ended December 31, 2016 ("2016"), the Company incurred a net loss of \$224,112 (\$0.01 per share) compared to a net loss of \$10,230,524 (\$0.57 per share) during the year ending December 31, 2015. The administrative expenses for 2016 were \$196,321, up from \$178,242 from 2015. Total administrative expenses includes two non-cash expenses, amortization and stock-based compensation, these amounts were \$2,968 (2015: \$3,876) and \$42,831 (2015: \$Nil) in 2016, respectively. Excluding amortization, the 2016 administrative expenses were \$150,522 down from \$174,366 in 2015. Office and general expenses in were \$101,804 (2015: \$101,559), an increase of \$245. Investor relations in 2016 were \$12,540 (2015: \$15,263), a decrease of \$2,723, legal and audit in 2016 were \$18,178 (2015: \$19,544) a decrease of \$1,366. Management fees in 2016 were \$18,000, down \$20,000 from the \$38,000 incurred in 2015. Excluding amortization and stock-based compensation, the total general and administrative expenses for 2016 were approximately \$12,550 per month compared to \$14,530 per month in 2015. At December 31, 2016 the Company impaired the Turnagain mineral claims by \$29,093 (2015: \$10,055,858) to \$1 based on the current nickel prices, the global over-supply of nickel held in inventories and the weaker than expected Chinese and European demand. During 2016, the Company earned \$1,302 from interest income compared to \$3,576 for 2015.

Exploration - During the year ended December 31, 2016, the Company incurred expenditures on exploration and evaluation assets of \$29,093 (2015: \$69,699). The exploration expenditures for 2016 were approximately \$2,425 per month compared to \$5,800 per month in 2015. In June 2015, the Company received \$150,000 from the return of one of its reclamation deposits.

## 1.6 Liquidity and 1.7 Capital Resources

At December 31, 2016, the Company had working capital of \$89,698 compared to working capital of \$22,627 as at December 31, 2015. Accounts payable and accrued liabilities at December 31, 2016 were \$14,970. As of the date of expiry April 1, 2017, none of the 1,686,693 warrants subject to the accelerated exercise clause were exercised. The Company's budget for administrative and care and maintenance of the Turnagain property for the fiscal year ending December 31, 2017 is approximately \$200,000. As of the date of this report, the Company does not have sufficient funds to meet this budget and will need to raise additional funds through private placements, loans or joint ventures.

## 1.10 Fourth Quarter- N/A

Excluding adjustments for BC refundable mining tax credits of \$7,273 and property impairment of \$29,093, deferred exploration costs for the fourth quarter were \$6,000, at par with the costs expended in the third quarter of 2016, and down from the \$12,735 expended in the fourth quarter of 2015.

Excluding amortization and stock-based compensation, there were \$48,837 of administrative expenses during the fourth quarter of 2016; these expenses were up from the \$30,704 expended in the third quarter of 2016 and up from the \$26,662 expended in the fourth quarter of 2015.

## New standard IFRS 9 "Financial Instruments"

New standard IFRS 9 "Financial Instruments" is a partial replacement of IAS 39 "Financial Instruments: Recognition and Measurement". IFRS 9 uses a single approach to determine whether a financial asset is measured at amortized cost or fair value, replacing the multiple rules in IAS 39. The approach in IFRS 9 is based on how an entity manages its financial instruments in the context of its business model and the contractual cash flow characteristics of the financial assets.

The new standard also requires a single impairment method to be used, replacing the multiple impairment methods in IAS 39. IFRS 9 is effective for annual periods beginning on or after January 1, 2018. The Company is currently assessing the impact this new standard will have on its consolidated financial statements.

IFRS 16 "Leases" replaces IAS 17 "Leases" and the related interpretative guidance. IFRS 16 applies a control model to the identification of leases, distinguishing between a lease and a service contract on the basis of whether the customer controls the asset being leased. For those assets determined to meet the definition of a lease, IFRS 16 introduces significant changes to the accounting by lessees, introducing a single, on-balance sheet accounting model that is similar to current finance lease accounting, with limited exceptions for short-term leases or leases of low value assets. Lessor accounting is not substantially changed. The standard is effective for annual periods beginning on or after January 1, 2019, with early adoption permitted for entities that have adopted IFRS 15. The Company has not yet assessed the future impact of this new standard on its financial statements.

Other accounting standards or amendments to existing accounting standards that have been issued but have future effective dates are either not applicable or are not expected to have a significant impact on the Company's consolidated financial statements.

## 1.14 Financial Instruments and other Instruments

The Company is exposed in varying degrees to a variety of financial instrument related risks as follows:

## Credit Risk

Credit risk is the risk that one party to a financial instrument will fail to discharge an obligation and cause the other party to incur a financial loss. The Company's primary exposure to credit risk is on its bank accounts. The Company's bank accounts are held with a major bank in Canada. As all of the Company's cash are held by one bank in Canada, there is a concentration of credit risk. This risk is managed by using a major bank that is a high credit quality financial institution as determined by rating agencies. The Company is not exposed to credit risk on mineral tax credit receivable, as these are due from the Government of Canada. Significant areas requiring the use of management estimates include the determination of qualifying expenditures for refundable and non-refundable mining tax credits and the timing of receipt of refundable mining tax credits. Changes in interpretation of the relevant legislation and rules governing these mining tax credits may result in adjustments to the credits recorded in the statements as well as the timing of receipt of these mining tax credits.

## Currency Risk

The Company mainly operates in Canada and is therefore not exposed to significant foreign exchange risk arising from transactions denominated in a foreign currency.

## Liquidity Risk

Liquidity risk arises through the excess of financial obligations over available financial assets due at any point in time. The Company's objective in managing liquidity risk is to maintain sufficient readily available reserves in order to meet its liquidity requirements at any point in time. The Company achieves this by maintaining sufficient cash and banking facilities.

## Market Risk

Market risk is the risk that changes in market prices, such as foreign exchange rates, commodity prices and interest rates will affect the Company's net earnings or the value of financial instruments. The objective of market risk management is to manage and control market risk exposures within acceptable limits, while maximizing returns.

## Foreign currency exchange rate risk and commodity price risk

Foreign exchange risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in foreign exchange rates. Commodity price risk is the risk that market values and future incomes will fluctuate because of changes in commodity prices. The Company does not have any direct exposure to foreign currency exchange rate risk or commodity price risk. The Company had no forward exchange rate contracts or commodity price contracts in place during the years ended December 31, 2016 and 2015.

## Interest Rate Risk

Interest rate risk is the risk that future cash flows will fluctuate as a result of changes in market interest rates. As at December 31, 2016 and 2015, the Company did not have any significant interest rate risk.

The Company had no interest rate swap or financial contracts in place as at December 31, 2016 or 2015.

## 1.15 Other

## Capital Management

The Company identifies capital as share capital, cash and receivables that are expected to be realized in cash. The Company raises capital through private and public share offerings and related party loans and advances. Capital is managed in a manner consistent with the risk criteria and policies provided by the board of directors and followed by management. All sources of financing and major expenditures are analyzed by management and approved by the board of directors.

The Company's primary objectives when managing capital is to safeguard and maintain the Company's financial resources for continued operations and to fund expenditure programs to further advance mineral property interests. The Company is meeting its objective of managing capital through detailed review and due diligence on all potential acquisitions, preparing short-term and long-term cash flow analysis to maintain sufficient resources. The Company is able to scale its expenditure programs and the use of capital to address market conditions by reducing expenditure and the scope of operations during periods of commodity pricing decline and economic downturn.

There are no externally imposed capital restrictions and no changes in approach.

### Disclosure Controls and Procedures

Disclosure controls and procedures are designed to provide assurance that all relevant information is gathered and reported to the senior management, which includes the Company's President and its Chief Financial Officer, on a timely basis so that appropriate decisions can be made regarding public disclosure. As of December 31, 2016, the President and Chief Financial Officer have evaluated the effectiveness of the Company's disclosure controls and procedures as defined in *Multilateral Instrument 52-109, Certification of Disclosure in Issuers' Annual and Interim Filings*, of the Canadian Securities Administrators and have concluded that such disclosure controls and procedures are effective.

### Internal Control over Financial Reporting

The Company's President and the Chief Financial Officer are responsible for establishing and maintaining the Company's internal controls over financial reporting in accordance with *Multilateral Instrument 52-109*. These internal controls over financial reporting were effective as at December 31, 2016. There have been no changes in these controls during the fourth quarter of 2016 which have materially affected, or are reasonably likely to materially affect, the Company's internal controls over financial reporting.
